GENERAL TERMS AND CONDITIONS

THE HOLDER OF THIS TICKET VOLUNTARILY ASSUMES ALL RISK AND DANGER OF PROPERTY LOSS AND PERSONAL INJURY INCIDENTAL TO THE GAME OF BASEBALL AND RELATED ACTIVITIES AT FENWAY PARK, INCLUDING SPECIFICALLY (BUT NOT EXCLUSIVELY) THE DANGER OF BEING INJURED BY THROWN OR FLYING BATS AND THROWN OR BATTED BALLS.
