TERMS AND CONDITIONS

This Ticket represents a revocable license (the "License") and is issued by the New York Yankees Partnering ("the Yankees") to the Licensee pursuant to certain terms and conditions including those set forth below. In addition, Season Tickets and the applicable premium ticketing event purchase which this Ticket is issued (e.g., Legends Club, Champions Club, Luxury Club, Main Level Outdoor Suite, Terrace Level Outdoor Suite, etc.), the premium ticketing event shall contain governing Subject to the Fan Check Policy, a form below. This Ticket grants the bearer the rights: (a) enter the publicly accessible areas of Yankee Stadium (the "Stadium") as determined by the Yankees; (b) attend the New York Yankees Baseball Club (the "Club") game identified by this Ticket the "Game"; and (c) sit in the seat location identified on this Ticket during the Game.

Any violation of the License shall give the Yankees the unrestricted right to revoke this License, terminate this License and/or cancel the Ticket Account immediately without having to refund the established price (i.e., the face value) of this Ticket. This Ticket may not be used for advertising or promotion (including contracts, giveaways, or sweepstakes) or other trade or commercial purposes without the express written consent of the Yankees. The use of this Ticket or commercial other transactions involving this Ticket in violation of the License, with or without the knowledge of the Licensee, is the sole responsibility of the Licensee, who shall remain absolutely and unconditionally responsible for any violation of the License. Accordingly, the Licensee should continuously supervise the use of this Ticket so that the License is not violated. Transfer of License. Any director, individual, resale, auction, or assignment or transfer (collectively, "transfer") of this Ticket must be done in accordance with applicable law. Any resale or attempted resale in violation of applicable law violates this License.
