This Ticket represents a revocable license (the "License") and is issued by **ATM Ticket Manager** ("ATM") to the Licensee pursuant to certain terms and conditions including those set forth below. In addition, Season Tickets are subject to the terms and conditions contained on: (i) the Ticket, (ii) the Season Ticket Invoice, and (iii) the Season Ticket Booklet, and in the event of a conflict in the terms and conditions among the preceding (i), (ii) and/or (iii), the terms and conditions of the Season Ticket Invoice shall control and govern. In the event of a conflict between the terms and conditions of this License and the applicable premium ticket agreement pursuant to which this Ticket is issued (e.g., Legends Suite, Champions Suite, Luxury Suite, Delta Sky 360 Suite, Jim Beam Suite, etc.), the premium ticket agreement shall control and govern. Subject to the Rain Check Policy set forth below, this Ticket only grants the licensee the right to: (a) enter the public-accessible areas of Yankee Stadium (the "Stadium") at times determined by the Yankees; (b) attend the New York Yankees Baseball Club (the "Club") game identified on this Ticket (the "Game"); and (c) sit in the seat location identified on this Ticket during the Game.

Any violation of the License shall constitute a violation of this License, terminate the License and/or immediately void the License without having to return the established price (i.e., the face value) of this Ticket. This Ticket may not be used for advertising, promotion (including contests, giveaways or sweepstakes) or other trade or commercial purposes without the express written consent of the Yankees. The use of this Ticket for commercial or other purposes, including this Ticket in violation of the License, with or without the knowledge of the Licensee, is the sole responsibility of the Licensee, who shall remain absolutely and unconditionally responsible for any violation of the License. Accordingly, the Licensee shall defend and hold the Yankees and the Yankees and any person using this Ticket harmless from and against all claims, damages, losses and expenses, including reasonable attorneys' fees, that may be asserted against the Yankees or any person in possession of this Ticket as a result of the Licensee's or any person's use of this Ticket in violation of the License. The failure of the Licensee or any person in possession of this Ticket to cooperate with any investigation constitutes a violation of the License. The Yankees reserve the right, with or without refunding the established price (i.e., the face value) of this Ticket, to revoke the License, refuse admission or eject any person whose conduct as determined by the Yankees is disruptive, who is abusive in language, who is intoxicated with the terms and conditions of the License or who interferes with any ball in the field of play or any player attempting to make a play on any batted, pitched or thrown baseball. In addition, entering the playing field, disrupting a game and/or altering any physical contact with a game participant, including the umpire, is a crime punishable by law and/or improvement as well as a civil penalty of up to \$20,000. Violators will be prosecuted to the fullest extent of the law. Violation of any of the foregoing, as determined by the Yankees, by the Licensee or any person using this Ticket, may lead to the revocation of the License and termination of the Ticket Access. In addition, the Licensee and any person using this Ticket shall not attach, hang or display any signs, banners, advertisements or other notices in the Stadium.

Resale of Tickets: Any direct or indirect sale, resale, auction, assignment or transfer (collectively, "resale") of this Ticket must be done in accordance with applicable law. Any resale or attempted resale in violation of applicable law violates this License. This Ticket may not be resold within one thousand five hundred feet from the physical structure of the Stadium (including any building or any structure at which Ticket are offered for first sale to the public) under penalty of law. THE YANKEES ARE NOT RESPONSIBLE FOR TICKETS PURCHASED THROUGH STUBHUB.
